Narrative Summary. Below is the financial report of the parish for 2021-2022 and the budget for the current year, 2022-2023. On a promising note in our revenue report, the loose plate collection increased from \$61,910 in 2020-2021 to \$116,394 in 2021-2022. I believe this change reflects our visitors' return this past year to join us for Mass. Adult envelop contributions, on the other hand, decreased from \$346,262 in the prior year to \$308,508 in 2021-2022. This is likely the effect of other fundraising that was done in the parish during the year, including the money that was donated for our start-up fund and for the West Side Improvement Project. Currently, St. Mary's is a parish of 358 families and 709 members, down from 364 families and 747 members just a year ago. In 2020, our parish was 416 families and 850 members. The 2022-2023 budget is beginning to reflect our change in size and capacity.
